Curriculum Enhancement Week Organisation

For the week of 15th July 2024, the normal school timetable will be suspended, and pupils and staff will pursue one of the many activities detailed in the CEW booklet. This year we are offering a wide variety of high-quality activities. While we try very hard to accommodate choices, **we cannot guarantee every pupil will be allocated their first-choice activity but we hope to allocate one of the four.** Please read the descriptions closely, discuss the activities with your child and carefully **choose four different activities.**

Payment for Activities

- **In line with our charging policy, no pupil will be allowed to participate in an activity unless full payment has been made before the activity commences.**
- All costs are approximate and depend upon the final numbers of pupils taking part in each activity so may be subject to change.
- A trip may be withdrawn if it is not financially viable.

We offer a range of activities including low cost and free activities. Once your son or daughter has been allocated a place on an activity you will be notified via ParentMail and you will be asked to pay a non-refundable deposit on or before **1st December 2023 to secure the place. All activities must be paid for in full by 16th April 2024.** **PLEASE NOTE: Overnight trips will require short notice deposits once allocated and must be paid for in full by 22nd March 2024.** We understand this may seem early however, the school must book and pay external providers in full for the activities according to their terms and conditions.

Please be aware that once a deposit is paid, should your child fall ill or for any other reason you decide not to take part in an activity, the school insurance will not cover this. The school can offer no refund unless a replacement student takes their place. Once a deposit has been made and the school makes a booking, you are obliged and agreeing to pay the full cost of the activity; the school cannot be expected to lose money through no fault of its own.

Payments should be made online using ParentMail at www.parentmail.co.uk or via the ParentMail App. Instalment payments are **the compulsory minimum amount required** by that date to allow the school to pay providers. You can choose to pay more than the minimum instalment or in full for your allocated activity at any time before the final payment deadline of Tuesday 16th April 2024.

Pupils' Personal and Medical Details

All medical information will be taken from our central records except where additional information is needed for those activities planning overnight stays; further individual details may be requested and a parental meeting concerning the visit will be organised if necessary. Activity Choice Form

This form must be completed online in Parentmail forms.

PLEASE DO NOT PRINT the form to hand in as this will delay your submission.

- Please take the time to carefully consider choices and **choose 4 different** activities which are of interest.
- There is no rush to be the first to respond. All forms submitted on Monday 6th to Tuesday 7th November by 12pm (noon) will be treated as arriving at the same time.
- Oversubscribed activities will be subject to a draw. For impartiality, the draw will be made by the Headteacher.
- Forms submitted after 12pm (noon) on Tuesday 7th November will be allocated using the "first come first served" basis for activities with spaces left..
- In order that all students have fair access to all the activities, **if a student has attended an activity in the previous years, it should not be their first or second choice.**

Activities will not be allocated if the Student Details Form is not filled in with four different choices and the form will be resent for completion, delaying your submission.

Attendance

Curriculum Enhancement Week is an important part of your child's education at this school and full attendance is expected and required. Reasons and notifications for non-attendance will be required as usual: every absence must be supported by a parental explanation letter/email.
